1. A person five or fewer years removed from a full-time undergraduate or graduate engineering program accredited by ABET may be eligible for a discounted dues rate. be invoiced. Renewal rates vary depending on your state and chapter. Membership rates are subject to change.
2. A person who meets the requirements for Licensed Member of Member, but who resides outside the United States, its territories, possessions, or districts, may join as an At-Large Member for \$110.
3. Contributions (or gifts), dues and fees to NSPE are not tax deductible as charitable contributions for federal income tax purposes. However, they may be tax deductible as ordinary and business expenses.
